## 2010 CDBC TEAMS:

Welcome to Calgary Dragonboat Club - CDBC CREW YAHOO. We are a team of passionate paddlers which has been in existence for over 17 years. Though our Team has fluctuated in its membership base over the years, the core of our Crew has consisted of two or more Teams - CREW YAHOO, YAHOO EVOLUTION, and YAHOO ANGELS. The make up of the team(s) are subject to change based on the membership mix. Members of all Crews are expected to participate in fund raising events to help support the Club's training program and to help reduce the cost of out of town Festivals. Crew members are selected at the sole discretion of the coaches. Below are the team descriptions for the 2010 Teams.

### CREW YAHOO – COMPETITIVE MIXED

This Crew will consist of competitive mixed paddlers. This Crew will focus on maximizing competitive performance throughout the season. Practice commitments are a minimum of twice (2) weekly and participation in at least one out of town Festival. Additional fees of \$20 will be applied to the Competitive Mixed Team to help cover the cost of the additional practices. Practices will be held on Thursday evenings and Sunday mornings.

### YAHOO EVOLUTION – RECREATIONAL MIXED

This Crew will consist of recreational mixed paddlers. This Crew will focus on developing Paddler's skills and is designed for those with time restrictions. Practice commitments are a minimum of once (1) weekly and participation in at least one Festival.

### YAHOO ANGELS – WOMEN'S

This Crew will consist of female paddlers who are looking for a competitive outlet with an all female team. Depending on participation levels, it may be possible for female paddlers from the Mixed Crew to be a part of YAHOO ANGELS.

## FEES:

Club Membership Fees: \$60

All fees must be submitted along with the membership form. Additional Race Entry, travel, and accommodation fees will apply for all Festivals. Fees will be announce once the Race entry fees have been confirmed by the independent Festivals. Membership fees are subject to change and are based on 2009 practice rates. \*Refunds will only be provided on a case by case basis. Refunds are subject to an admin fee of \$5.00 and will be sent out at the end of the season.
